We invite you to our meeting with Dr. Kent Pekel to get the facts about the Rochester Public Schools 2024 Referendum.

As part of the general election on November 5, RPS District voters will consider a proposal to increase the school operating levy per pupil annually. This investment would raise revenue for ten years to help protect staffing levels, class sizes, and student programs and services. I attended the historical play, "A Time for Women: 150 Years of Leadership" in Lanesboro. It is the story of the suffrage movement illustrated by actresses portraying women activists from southeast Minnesota and Minneapolis. They fought for women both locally and nationally. Sarah Stearns from Rochester worked hard with the MN legislature to pass a constitutional amendment for women to vote beginning in 1867. In 1920, Tennessee was the 36th state to ratify the amendment, resulting in the 2/3 majority needed, and the 19th amendment was ratified.

Now we are waiting on the ratification of the ERA. Congress has delayed passing the ERA amendment to the national constitution. AAUW will again be supporting the ERA amendment to the MN constitution. We will work with legislators to vote in favor of having the amendment placed on the ballot for MN voters to approve.

Unfortunately, the fight for women's rights and equality is not over. The 2024 elections matter. This fight isn't just about one issue – it's about the foundation of our lives and our futures. Therefore, I urge you to vote for the candidates this year who will continue to support women.
